## **FOREWORD**

The 9'th edition of the National Conference on Pharmacoeconomics and Healthcare Management (NCPHM) will be organized again in the classical way (i.e., on-site). On-line presentations will be held only in special circumstances.

The present edition is proposing a diverse, but nevertheless ambitious programme, offering answers to some of the frequently asked questions generated by the recent challenges that we are facing, including the pandemics, war, economic hyperinflation...

EU states including those from the ECE region are exposed to external shocks such as the Covid-19 pandemics, the consequences of the war, economic crisis, hyperinflation, migration



of health workers, demographic decline ... and health systems have to face all these challenges.

Besides these major challenges, the states from this region have another major problem: their health system is tackling a considerable lack of infrastructure, funds and last but not least, administrative capacity and system management.

Romania - similar to other former socialist states from the East-European block that have become members of the EU – is dealing with the above-mentioned challenges, while its citizens are having ever-evolving expectations towards the decision-makers, healthcare service providers and healthcare professionals.

Although in recent years there has been a considerable surge in the volume of healthcare system financing, a seemingly permanent financing gap exists, with ever-evolving unmet needs. Meanwhile, the efficient resource utilization remained a minor issue, and is regaining its importance in recent times, at a system level.

The objectives of the present edition of the NCPHM are in concordace with the already mentioned challenges that our healthcare system is facing.

Defining itself as a forum for exchanging ideas related to the healthcare system, NCPHM is acting a mediator between the stakeholders of the healthcare system.

The NCHMS aims to contribute to increasing the administrative capacity of the health system by disseminating knowledge through courses, analyses and presentations by experts, to provide the framework for professional and scientific debates in the field of pharmacoeconomics and health management.

Furthermore, our objective is also to bring together academics and PhD students in pharmacoeconomics, health management and public health.

In order to facilitate the attendance of specialists from public and educational institutions, the NCHMS will offer the possibility of free participation for experts involved in the development and implementation of health policies, thus contributing to their professional development.
